

**OFFICIAL RULES – NXWORRIES MYSTERY BOX GIVEAWAY**

**1. HOW TO ENTER:** No purchase or payment is required to enter the NxWorries Mystery Box Giveaway (the “**Promotion**”). Any purchase or payment will not increase your chance of winning the Promotion. The Promotion begins on June 14, 2024 and ends on July 19, 2024 (the “**Promotion Period**”). Throughout the Promotion Period, you must follow the steps outlined in Section 1(a)-(c) below. Online entry to this Promotion by Blockchain Game Partners, Inc. d/b/a “Gala Music” (“**Sponsor**”) is the only method of entry and limited to one (1) Gala account. Judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.
