

# \$GALA Referral Rewards Terms and Conditions

## 1. Program Overview

The \$GALA Referral Rewards Program ("Program") offers participants the opportunity to earn \$GALA tokens ("Rewards") by referring new users to create Gala accounts and make qualifying purchases. Participation in the Program is subject to the following terms and conditions ("Terms"). "\$GALA token" is defined in the GALA Terms and Conditions found at: <https://www.gala.com/legal/gala-terms-and-conditions>

## 2. Eligibility

In order to be eligible to receive the Rewards a participant ("Player") must have an active GalaChain wallet and provide the GalaChain wallet address in the Telegram mini app. Gala reserves the right to determine eligibility at its sole discretion.

## 3. Referral Payout Structure

Every GALACoin Player is eligible to receive the following \$GALA bonuses, which will be credited directly to their account that can be withdrawn once the minimum threshold of twenty (20) \$GALA is reached. Referral Payout Structure will be as follows:

- **One (1) \$GALA** – Awarded when Player creates a new Gala account through [games.gala.com](https://games.gala.com)
- **Five (5) \$GALA** – Awarded when Player makes their first Gala purchase of at least One and 00/100 US Dollars (\$1.00 USD)
- **Half (0.5) \$GALA** – Awarded when Player's referred user creates a new Gala account
- **Five (5) \$GALA** – Awarded when Player's referred user makes their first Gala purchase of at least \$1.00 USD

## 4. Withdrawing \$GALA

Players will be able to withdraw their \$GALA bonuses once they've accumulated at least twenty (20) \$GALA tokens. The withdrawal will happen within the Telegram mini app. Player's withdrawn \$GALA will appear in the GalaChain wallet within seventy two (72) hours after withdrawal is initiated.

## 5. Legal Disclaimers

**No Guarantee of Earnings:** Participation in the \$GALA Referral Rewards Program does not guarantee any specific amount of rewards. The amount of \$GALA earned through referrals is

contingent on the actions of the referred individuals and your continued participation in the program.

**Changes to the Program:** Gala reserves the right to modify, suspend, or terminate the \$GALA Referral Rewards Program at any time, without notice. Changes may include, but are not limited to, adjustments in the referral payout structure, eligibility requirements, or withdrawal thresholds.
